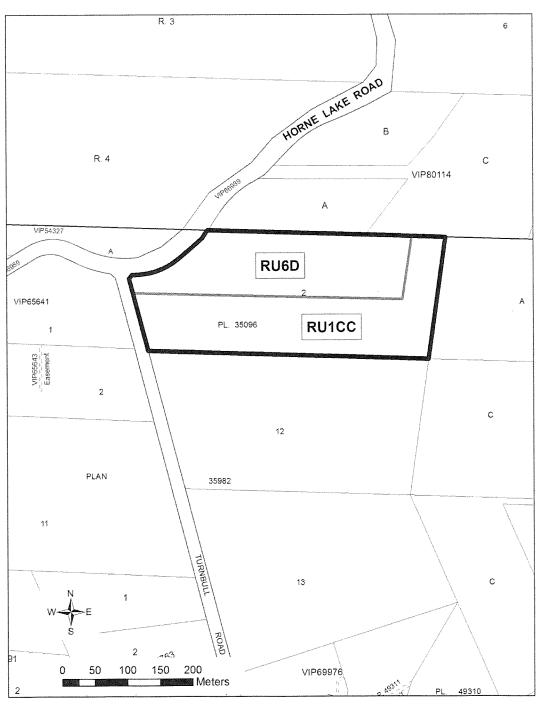

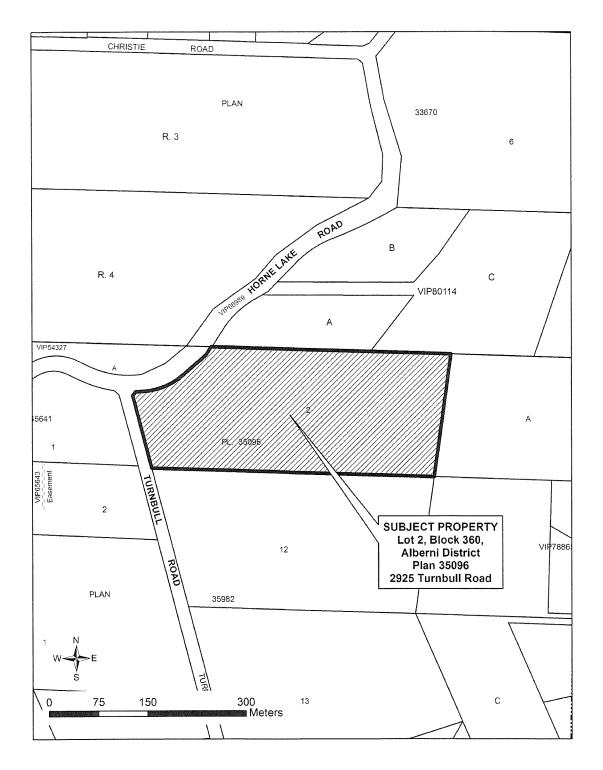

Attachment 4 Conditions of Approval for Zoning Amendment Application

The following items shall be registered at Land Titles office as a Section 219 Restrictive Covenant, prepared at the applicant's expense and to the satisfaction of the Regional District of Nanaimo prior to Amendment Bylaw No. 500.382, 2013 being considered for adoption:

- 1. The Preliminary Hydrogeological Assessment Report prepared by Lewkowich Engineering Associates Ltd. dated December 27, 2012 be registered on the title of the subject property, and require that future subdivision and construction activities be consistent with the recommendations contained in the report.
- 2. Require that wells on proposed Lots 1 and 2 be constructed, tested, and a report submitted to the RDN in compliance with Policy B1.21 prior to building permit application of any residential dwelling on each parcel created through subdivision (see Well Report Requirements below). In addition, require that the existing well on Lot 3 be tested by a qualified professional and a report submitted to the satisfaction of the Regional District, to ensure the well meets the Canadian Drinking Water Standards, and that a potable water supply of 3.5 m³ (3500L) per day is provided.

Well Report Requirements

The intent of the well report is to confirm that the well can adequately service the proposed lot and that it meets current well regulations. The report must be completed, dated and signed by a qualified professional and include/confirm the following:

- the date when the well was drilled along with a copy of the driller's log;
- the well identity number as indicated on the plate secured to the well;
- photographs of the well identity tag, 'stick up', and general location of the well;
- that the water meets the Canadian Drinking Water Standards. The report should include the test
 results of the well water and to have been completed within 6 months of the date of the report.
 The report must also identify where the parameters may have exceeded the Drinking Water
 Guidelines;
- that pump testing has been completed and witnessed by a qualified professional. The pump testing is required to have been run for the greater of twelve hours or until the water level stabilizes at the pumping rate of at least 2.5 litres/minute with a well recovery period monitored for the greater of 6 hours or until the water level recovers to a minimum of 90% of its prepumping water level. This pump test should be conducted only during the months of July through November (lowest water table).

PURPOSE

To consider "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.379, 2013" for adoption.

BACKGROUND

The proposed Amendment Bylaw No. 500.379 (see Attachment 1) was introduced and given first and second reading on March 26, 2013. A Public Hearing was held on April 8, 2013, and the Bylaw received third reading on April 23, 2013. The Ministry of Transportation and Infrastructure approved the Bylaw on May 1, 2013. Following the close of a Public Hearing no further submissions or comments from the public or interested persons can be accepted by members of the Board, as established by provincial case law. Having received the minutes of the Public Hearing eligible Board members may vote on the Bylaw.

As a condition of rezoning approval, and prior to the adoption of the Bylaw, the applicant was required to complete the following:

- 1. Provide a community amenity contribution in the amount of \$32,000 for the future development of a multi-use trail within the Stanhope Road right-of-way.
- 2. Provide a security for the future construction of a soft surface trail within the proposed park land dedication to the satisfaction of the General Manager of Strategic & Community Planning. The trail shall be secured prior to adoption and constructed prior to subdivision final approval.
- 3. Register a Section 219 restrictive covenant to ensure that future development on lots immediately adjacent to the park complies with the following criteria:
 - Fencing along the common boundary of the residential lot and the park shall be limited to low permeable fencing. It will also be encouraged that landscaping be maintained to provide visual surveillance to the park;

- Buildings and structures on lots where the rear lot line is common to the park shall be
 articulated with windows, porches, and decks that are oriented to provide maximum
 visual surveillance of the park. Points of access to the park, such as gates, will be
 encouraged to provide a direct connection to the park from each lot; and,
- Dumping of yard waste or refuse in the park area is prohibited.

In regards to conditions 1 and 2, the applicant has paid \$32,000 as a community amenity contribution for future trail improvements within Stanhope Road (an undeveloped road), and the applicant has secured the provision of a soft surface walking trail through the registration of a Section 219 covenant.

In regards to condition 3, the applicant has registered a Section 219 restrictive covenant on the property title to address the design of buildings and structures and fences along the common boundary between the proposed residential lots and park.

ALTERNATIVES

- 1. To adopt "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.379, 2013".
- 2. To not approve the Bylaw and provide alternate direction.

SUMMARY/CONCLUSIONS

The purpose of Amendment Bylaw No. 500.379, 2013 is to amend the zoning of the property located at 691 Wembley Road in Electoral Area 'G' to facilitate a proposed subdivision of the property into thirty-eight residential lots and park land dedication. The Amendment Bylaw was introduced and read two times on March 26, 2013; proceeded to Public Hearing on April 8, 2013; and received third reading on April 23, 2013. The Bylaw was approved by the Ministry of Transportation and Infrastructure on May 1, 2013, following which the applicant proceeded to complete the Conditions of Approval. Given that the applicant has addressed the Conditions of Approval, staff recommends that the Board adopt Amendment Bylaw No. 500.379, 2013.

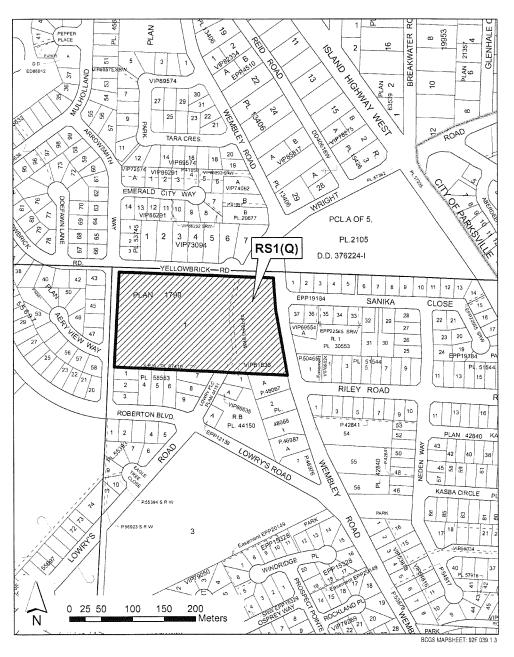

A Bylaw to Amend "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987"

The Board of the Regional District of Nanaimo, in open meeting assembled, enacts as follows:

- A. This Bylaw may be cited as "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.383, 2013".
- B. "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987", is hereby amended as follows:
 - 1. Under PART 2, INTERPRETATION, DEFINITIONS by adding the following definitions in alphabetical order:

"agri-tourism means a temporary and seasonal tourist oriented activity or service accessory to an agricultural use that promotes or markets products grown, raised, or processed on land that is classified as a 'farm' under the Assessment Act and in accordance with the Agricultural Land Reserve Use, Subdivision, and Procedure Regulation. Agri-tourism may include but is not limited to farm tours and demonstrations, farm related educational activities, and seasonal promotional events.

agri-tourism accommodation means the provision of temporary and seasonal accommodation accessory to an agricultural use for the travelling public within an agriturism accommodation sleeping unit on land that is classified as farm under the Assessment Act.

agri-tourism accommodation sleeping unit means a bedroom or other area used as a bedroom for the purpose of agri-tourism accommodation within an agri-tourism accommodation cabin, a tent or recreational vehicle in an agri-tourism accommodation campground or a bedroom within a dwelling unit.

farm retail sales means the sale to the public of products grown or raised on a farm, from that farm and may include the sale of non-farm products in accordance with the Agricultural Land Reserve Use, Subdivision, and Procedure Regulation."

2. Under PART 3 LAND USE REGULATIONS, SECTION 3.3 GENERAL REGULATIONS by adding the following new text after Section 3.3.13:

"14) Farm Use Regulations

On lands located within the Agricultural Land Reserve the following activities are permitted farm uses in accordance with the *Agricultural Land Reserve Use, Subdivision and Procedure Regulation* and are subject to the following regulations:

a) Agri-Tourism

Agri-tourism activities, other than accommodation, are permitted on land located within the Agricultural Land Reserve that is classified as 'farm' under the *BC Assessment Act*, if the use is temporary and seasonal, and promotes or markets farm products grown, raised or processed on the farm.

b) Farm Retail Sales

Farm retail sales is permitted on land located within the Agricultural Land Reserve if:

- i) All of the farm product offered for sale is produced on the farm on which the retail sales are taking place, or
- ii) At least 50% of the retail sales area is limited to the sale of farm products produced on the farm on which the retail sales is taking place and the total area, both indoors and outdoors, used for the retail sales of all products does not exceed $300 \, \text{m}^2$.

15) Agri-Tourism Accommodation

- a) As exceptions to Section 3 of the *Agricultural Land Reserve use, Subdivision and Procedure Regulation*, on parcels within the Agricultural Land Reserve and where agri-tourism accommodation is a permitted accessory use, the following general provisions apply:
 - i) Agri-tourism accommodation use must be for rental only;
 - ii) Agri-tourism accommodation is permitted only on land classified as 'farm' under the *BC Assessment Act*;
 - iii) A maximum of ten (10) agri-tourism accommodation sleeping units including seasonal campsites, seasonal cabins or short term use of bedrooms within a dwelling unit are permitted in accordance with the *Agricultural Land Commission Ac*;.
 - iv) The total developed area for an agri-tourism accommodation use, including buildings, landscaping, driveways and parking shall occupy less than five percent (5%) of the total parcel area, in accordance with the *Agricultural Land Commission Act*.

- b) An agri-tourism accommodation campground must be developed in accordance with the following regulations:
 - i) Every campsite shall be unpaved and not exceed 150 m² in area;
 - Washroom and drinking water facilities shall be provided for in accordance with the Vancouver Island Health Authority's regulations and/or provincial regulations;
 - iii) A maximum consecutive or non-consecutive stay of ninety (90) calendar days per visitor within any twelve (12) month period within any campsite on the parcel. The relocation of recreational vehicle (RVs) or campers to other sites within the parcel does not constitute the start of a new stay.
- c) An agri-tourism accommodation cabin must be developed in accordance with the following regulations:
 - i) The maximum gross floor area of an agri-tourism accommodation cabin shall not exceed 50 m²;
 - ii) Washroom and drinking water facilities shall be provided for in accordance with the Vancouver Island Health Authority's regulations and/or provincial regulations;
 - iii) A maximum of one kitchen facility shall be permitted within each agri-tourism accommodation cabin;
 - iv) A maximum consecutive or non-consecutive stay of ninety (90) days per visitor in any twelve (12) month period within any cabin on the parcel. The relocation of a visitor to another cabin within the parcel does not constitute the start of a new stay;
 - v) One (1) parking space per agri-tourism accommodation cabin is required."
- 3. Under PART 3 LAND USE REGULATIONS, Section 3.1 Zones by adding the following zoning classification and corresponding short title after Section 3.4 Regulations for Each Zone:

"Agriculture 1 (AG1)"

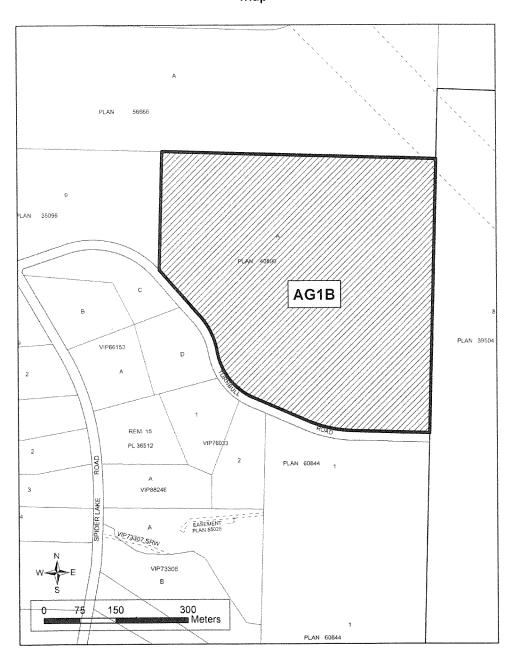

1. Schedule A of "Regional District of Nanaimo Electoral Area 'A' Official Community Plan Bylaw No. 1620, 2011" is hereby amended as follows:

a. Table of Contents

- i) By adding the following heading at the end of the Table of Contents "Village Plans Which Form Part of this Plan".
- ii) By adding "Schedule B: Cedar Main Street Village Plan" under the heading described in (i) above.

b. Section 2.3 Scope

By deleting the last paragraph and replacing with the following:

The Plan Area, including the lands subject to the Cedar Main Street Village Plan, is designated a 'development approval information area' pursuant to the RDN's Impact Assessment Bylaw No. 1165, 1999. This Bylaw outlines information requirements for zoning amendments, development permit applications, and applications for a temporary industrial or commercial use permit. The Cedar Main Street Village Plan is attached to and forms part of this Bylaw to provide detailed guidance on future land use and community preference and desirable changes within the Cedar Main Street Plan Area.

c. Section 2.5 Organization of the Plan

i) By adding the following text to the end of the paragraph:

The Electoral Area 'A' Official Community Plan includes Schedule A and Maps 1-10 which specify the policies and Development Permit Area Guidelines applicable to all of The Plan Area and Schedule B and Maps 1-4, the Cedar Main Street Village Plan which provides policies and Development Permit Area Guidelines specific to Cedar Main Street.

The Cedar Main Street Village Plan forms part of this OCP. The location and boundary of the Cedar Main Street Village Plan is shown on Map No. 3 Land Use Designations and Growth Containment Boundaries.

ii) By deleting Figure No. 2 - OCP Structure and replacing it with the diagram included in Attachment 1.

d. 6.2 Cedar Main Street

By deleting Section 6.2 and replacing with the following:

6.2 Cedar Main Street Village Plan

The Cedar Main Street Village Plan (Schedule B) is the principal guiding document for all land use decisions within the Cedar Main Street Village Plan. The Village Plan is based on the results of a Community Design Charrette held in 2012 and was adopted as a bylaw amendment to this OCP. The Design Ideas, Land Use Designations, Development Policies, Development Permit Area Guidelines, and implementation actions of the Village Plan detail community preferences and desirable changes within Cedar Main Street.

Future land use and other improvements within Cedar Main Street must be consistent with both the Official Community Plan and the Cedar Main Street Village Plan. Where a particular issue is not covered by the Cedar Main Street Plan, the Electoral Area 'A' Official Community Plan will take precedence within the Cedar Main Street Plan Area. Where a conflict exists between the OCP and the Cedar Main Street Village Plan, the designation or policies of the Cedar Main Street Village Plan will take precedence.

e. 12.6 Cedar Main Street Development Permit Area

By deleting Section 12.6 and replacing it with the following:

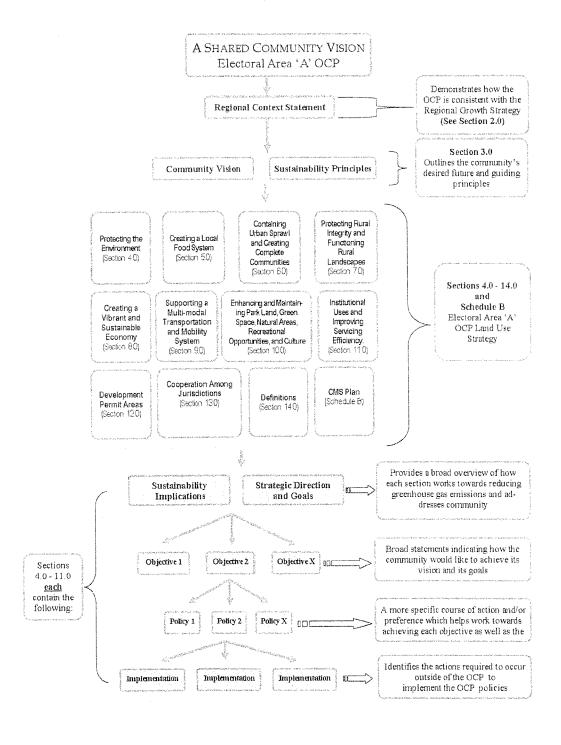

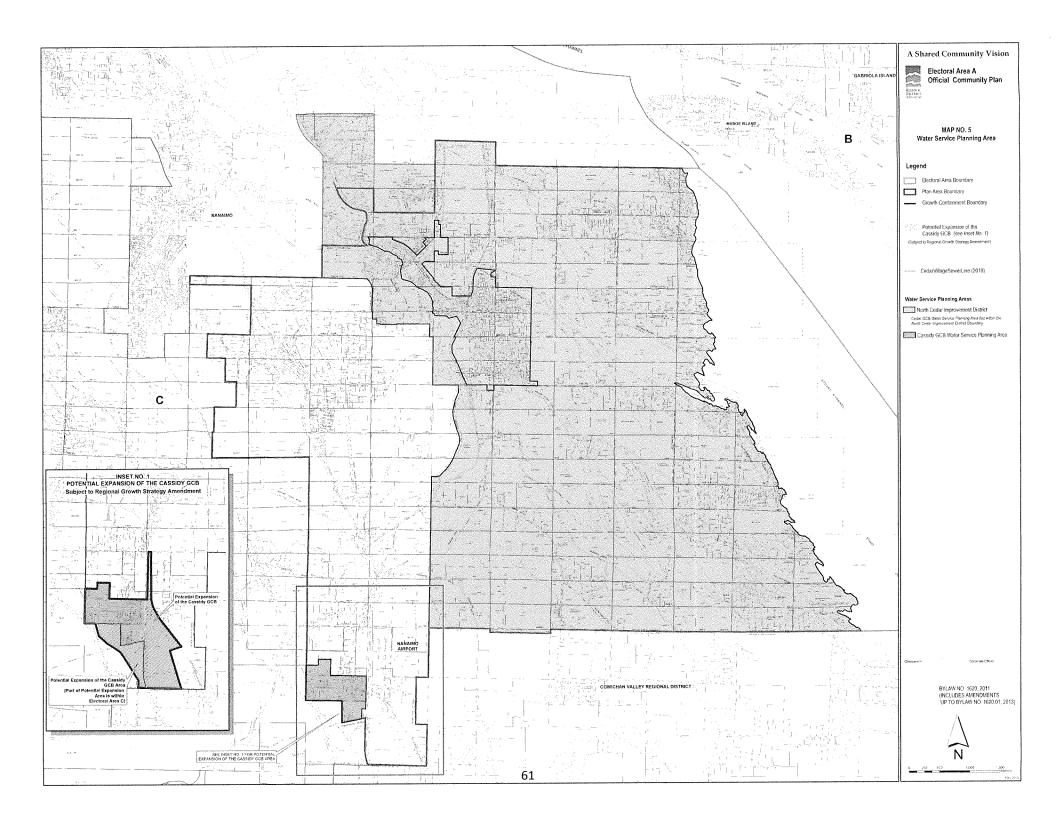

Map No. 3 Land Use Designations and Growth Containment Boundaries



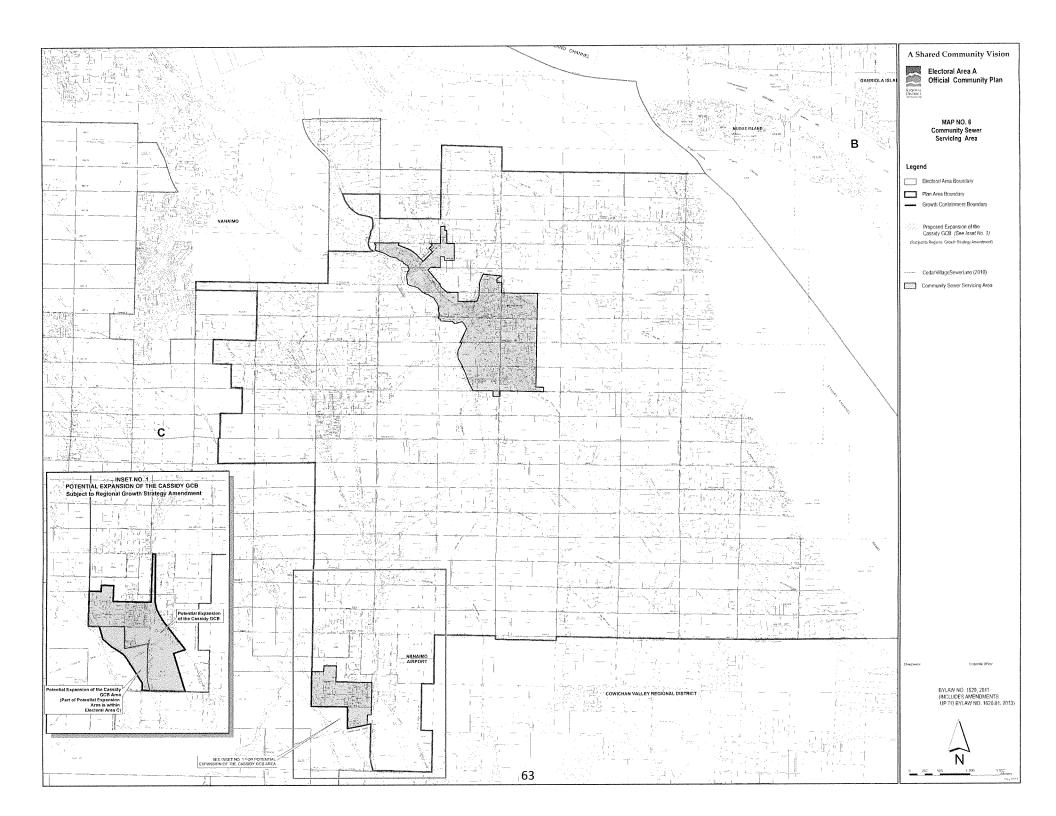

Map No. 5 Water Service Planning Area



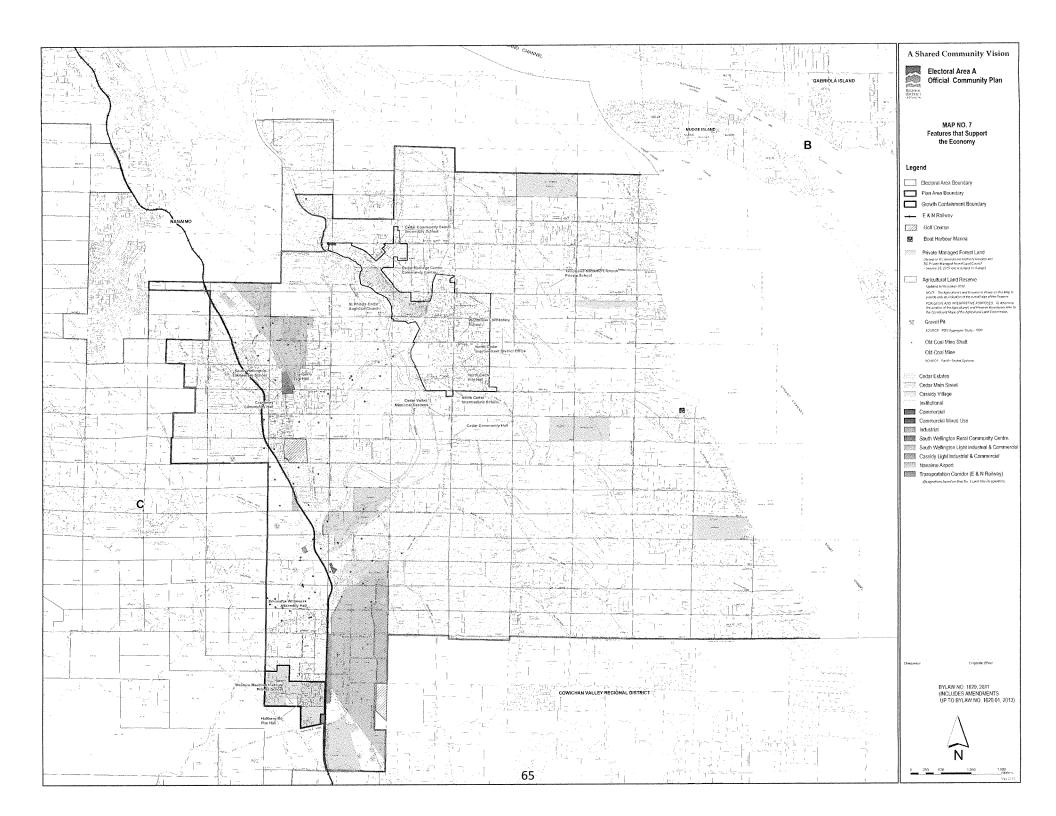

Map No. 6 Community Sewer Servicing Area



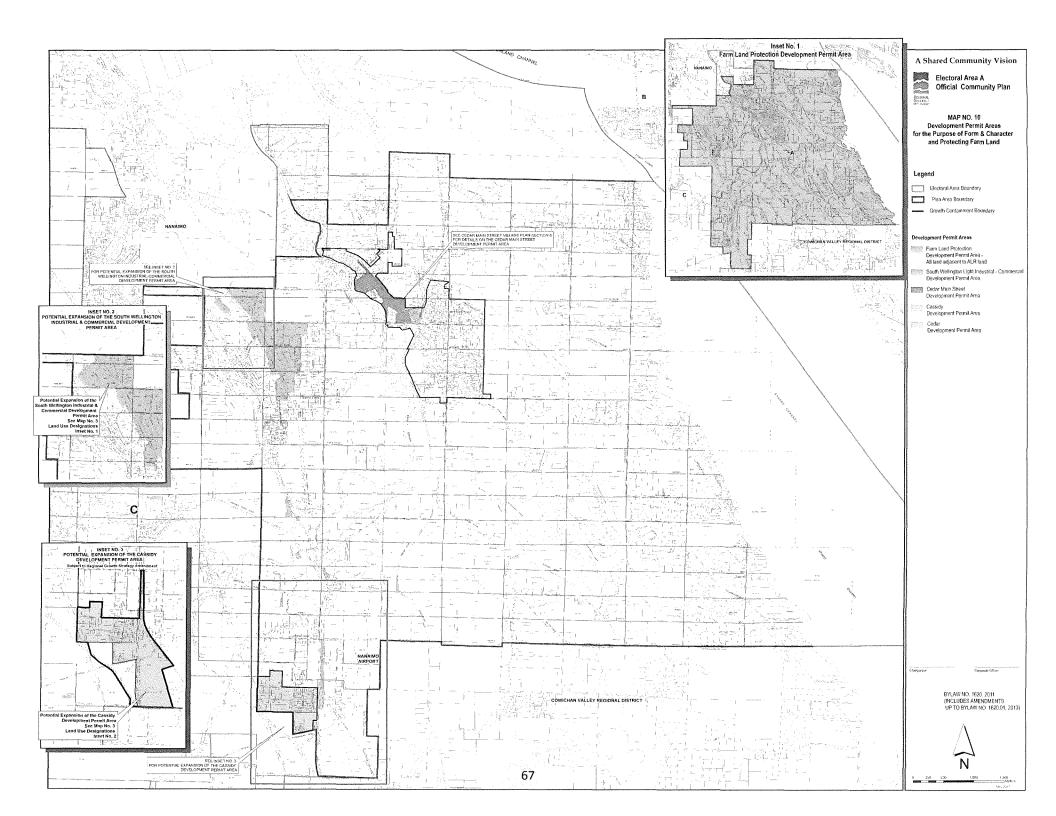

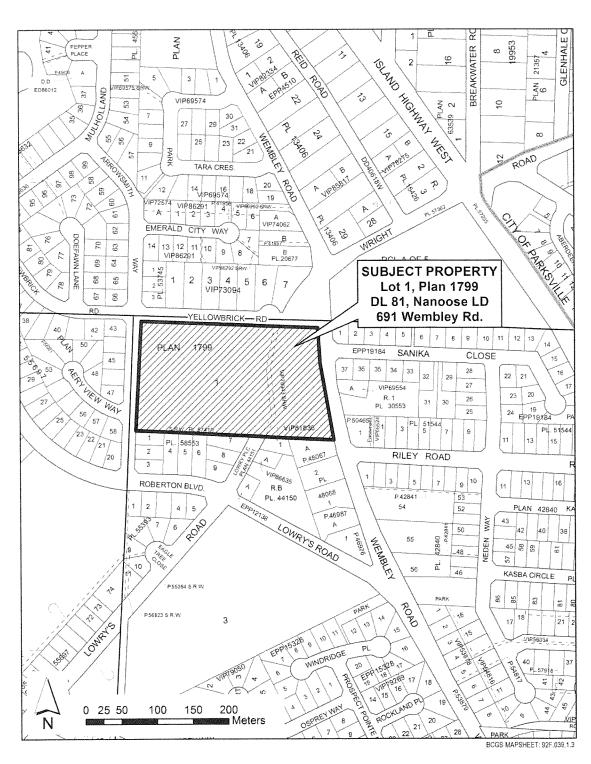

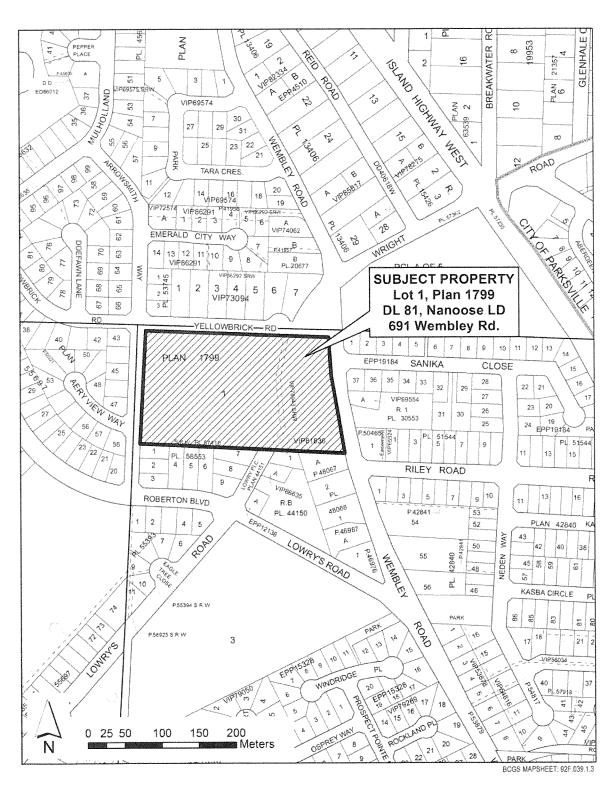

Ms. McCulloch gave an update of the Area A Community Parks and Trails Projects. She noted that the Nelson Rd. boat launch stairs have been repaired and re-opened for public use. Commissioner Fiddick said that in the first storm, it looks like the stairs could be wiped out again. Ms. McCulloch will provide further information regarding the stair design at a future meeting.

Ms. McCulloch said a covered sitting area may be a possibility in a future phase. Ms. McCulloch noted that with the lease of the adjacent lot for parking, the main entrance to the park is now on the west side; the south entrance will remain as an emergency/maintenance access.

Cedar Heritage Centre - Capital improvements Update

Ms. Pearson reported that the HVAC improvements were completed and building feels comfortable and warm. RDN Staff will meet in the near future to plan out the timing for the final efficiency updates (i.e., doors) and the 2013 capital projects (i.e., exterior painting, gutters and downspouts and landscaping).

Cedar School and Community Enhancement Society Agreement (verbal)

She noted that the agreement was not ready for the deadline for this meeting but it was agreed that it would be emailed to Commission members for their review and then forwarded to the next Regional Board meeting as per Director McPherson's suggestion.

Ms. Pearson noted the most significant change in the agreement is that it is now a Lease agreement, not a Licence of Use agreement due to the changes with not having RDN staff at the building. Electoral Area 'A' Recreation and Culture Budget 2013 Revision (March 26/13)

Chair McPherson spoke to the revision of the Electoral Area 'A' tax requisition for 2013 by an increase of \$25,000 for reserve fund purposes. The current bylaw allows the tax requisition funding to increase from the current tax level from. 10 to .15 to collect the additional \$25,000.

Parks - 5 Year Goals and Projects

The Commission had a discussion regarding the Five Year Parks Goals and Projects Plan. The Commissioners discussed and prioritized several project on the Five year plan and will finish the list at the next meeting in June. When the feedback discussions are completed, Ms. McCulloch will prioritize the projects in the Planning Worksheet for review.

COMMISSIONER ROUND TABLE

Commissioner Pagan – The proposed School District 68 facility plan has serious implications in Area 'A' especially regarding the closure of community fields and gyms.

Commissioner Grand – Reported she was a School Board trustee in Ontario and at that time, they could not close a school unless it sat unused for 5 years and had explored options for repurposing. She enquired as to whether the same process is required for School District 68. Director McPherson said it was a different process in the Province of BC.

Commissioner Jordan – She opposes any school closures and thinks the community will speak against it. She has had requests from people for an outdoor sports field with play park and exercise equipment.

Commissioner Vincent. – Would like to focus on trails and kids access around schools.

Commissioner Mead – School closures would affect children's recreation that use the school facilities.

B. White – Was surprised about the news of SD68 potential school closures. He is careful as to where he takes his children due to the dangerous roads. Transportation needs to be a priority. Will talk to Director McPherson about the local transit plan.

Director Bestwick noted the City of Nanaimo is currently undergoing a review of the City's Master Transportation Plan and strongly encouraged that the VIU Students' Union be involved in this process.

Director Lefebvre asked if routing was changed, how many more students would use transit. S. Beasley noted that it is more than a routing issue, transit must meet a range of needs including cost, connectivity, capacity and frequency. S. Beasley further noted that the Students' Union completed a survey and was able to create a map with the students' address. PURPOSE

To bring forward the 2013/2014 Conventional and Custom Annual Operating Agreement (AOA) for the Regional District of Nanaimo Transit System, with BC Transit, for consideration and approval.

BACKGROUND

The Annual Operating Agreement (AOA) (*Appendix 1*) between the Regional District of Nanaimo (RDN) and BC Transit is renewed on an annual basis and provides the cost-sharing service arrangements for Conventional and Custom Transit services in Districts 68 and 69 for the period of April 1, 2013 to March 31, 2014. The 2013/2014 AOA reflects an additional 5000 hours of Conventional transit service and 3750 Custom hours of service that were implemented in March 2014.

The AOA is an agreement governing items such as service specifications, payment schedules, fares and days/hours of service that will be provided for cost-sharing purposes. As with previous AOA's there are costs that fall outside of the scope of the annual agreement. These items include the RDN interdepartmental administration charges, fare product commissions paid to vendors, building rentals, bus stop maintenance, training for existing staff members (drivers), advertising done outside the AOA marketing budget and janitorial services.

FINANCIAL ANALYSIS

Conventional Transit:

The main changes in the AOA that should be noted include:

The costs above reflect a new conventional schedule that was expanded by an additional 5000 hours of annual service in March 2013. The changes noted above are the line items that make up the majority of the overall costs outlined in the AOA. The Conventional Transit costs are cost-shared with BC Transit at a current rate of 46.67%.

The main increases to the Conventional system in the 2013/2014 AOA are for increased variable hourly costs that include drivers' wages and benefits as well as costs of fuel, tires and maintenance. Fuel costs have increased based on a budget amount of \$1.30 per litre, versus \$1.26 per litre in 2012/2013.

The March 2013 expansion included three additional conventional buses being added to the fleet.

Custom Transit:

The main changes in the AOA that should be noted include:

The costs above reflect a new Custom schedule that was expanded by an additional 3750 hours of annual service in March 2013. The changes noted above are the line items that make up the majority of the overall costs outlined in the AOA. The Custom Transit costs are cost-shared with BC Transit at a current rate of 66.69%.

Staff had concerns with the Custom lease fee cost increases and asked BC Transit staff to provide detailed information on the cost of the new Arboc Custom buses. Staff were able to determine that the lease fees included in the AOA were only budget numbers and the RDN will be charged based on actual numbers, which BC Transit staff have said will be lower. RDN transit staff will continue to monitor lease fee costs to ensure actual costs are being charged. The lease fee costs have also increased due to thirteen (13) Custom buses being replaced in the 2013/2014 years.

In addition, BC Transit staff informed RDN staff that they use a 5% amortization rate for Custom vehicle lease fees. Finance staff have said that the Municipal Finance Authority of BC (MFA) lending rate for five (5) years is 2.15%. Staff are waiting for further information from BC Transit on why the MFA rate is not used.

The other main increases to the Custom system are for increased driver wages, fuel, tires and maintenance.

The March 2013 expansion included two additional Custom buses being added to the fleet.

ALTERNATIVES

- 1. That the Board approve the 2013/2014 Conventional and Custom Transit Annual Operating Agreement as presented.
- 2. That the Board not approve the 2013/2014 Conventional and Custom Transit Annual Operating Agreement and provide further direction to staff.

FINANCIAL IMPLICATIONS

Under Alternative 1 the 2013/2014 Conventional and Custom Transit AOA total budget is \$14,354,874, which is an increase of \$1,199,168 from the 2012/2013 AOA Amendment #1. Transportation Services staff and Financial Services staff have reviewed these costs and they are in line with the approved RDN 2013 budget for transit services.

Under Alternative 2, if the Board does not approve the AOA, it will remove BC Transit's obligation to cost-share in the service.

SUSTAINABILITY IMPLICATIONS

The Transportation Services Department is working continuously on improving the viability and efficiency of public transit. The Annual Operating Agreement is a fundamental agreement that allows the Regional District of Nanaimo to enter into a cost-sharing arrangement with BC Transit. Residents within the RDN rely on public transit, whether it is for Conventional or Custom transit. The options provided by public transit enable residents to leave their cars at home while they take the bus to work, to school, to medical appointments or for other equally important reasons.

SUMMARY/CONCLUSION

BC Transit has forwarded the Annual Operating Agreement covering the period April 1, 2013 to March 31, 2014 for the RDN Conventional and Custom (handyDART) Transit services. Transportation Services staff and Financial Services staff have reviewed this AOA in conjunction with the approved RDN 2013 budget for transit services.

The 2013/2014 Conventional and Custom Transit AOA indicates a budget of \$14,354,874 that is cost-shared between the RDN and BC Transit. Staff have reviewed the AOA costs for Conventional Transit and these can be explained by increased costs due to inflation and actual increases in service.

Staff recommend that the Board approve the 2013/2014 Conventional and Custom Transit Annual Operating Agreement with BC Transit.

RECOMMENDATION

That the 2013/2014 Conventional and Custom Annual Operating Agreement (AOA) with BC Transit be approved.

ANNUAL OPERATING AGREEMENT

BETWEEN:

THE REGIONAL DISTRICT OF NANAIMO

(the "Municipality" and the "Operating Company)

AND:

BRITISH COLUMBIA TRANSIT

(the "Authority")

WHEREAS the Municipality and the Authority are authorized to share in the costs of providing a Public Passenger Transportation System pursuant to the British Columbia Transit Act

WHEREAS the Municipality is authorized to operate, manage and maintain a Public Passenger Transportation System within the Nanaimo Regional Transit Service Area.

WHEREAS the parties hereto have entered into a Master Operating Agreement effective which sets out the general rights and responsibilities of the parties hereto

AND WHEREAS the parties hereto wish to enter into an Annual Operating Agreement which sets out, together with the Master Agreement, the specific terms and conditions for the operation of the Public Passenger Transportation System for the upcoming term.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the premises and of the covenants herein contained, the parties covenant and agree with each other as follows:

SECTION 1 - DEFINITION OF TERMS

- 1.1 <u>Definitions</u>: Unless agreed otherwise in the Annual Operating Agreement, the definitions set out in the Master Agreement shall apply to this Annual Operating Agreement including:
 - (a) "Annual Operating Agreement" shall mean this Annual Operating Agreement and any Annual Operating Agreement Amendment negotiated and entered into by the parties subsequent hereto;
 - (b) "Master Agreement" shall mean the Master Joint Operating Agreement, including any amendments made thereto;

SECTION 2 - INCORPORATION OF MASTER AGREEMENT

- 2.1 <u>Incorporation of Master Agreement into Annual Operating Agreement</u>: Upon execution, this Annual Operating Agreement shall be deemed integrated into the Master Agreement and thereafter the Master Agreement and the current Annual Operating Agreement shall be read together as a single integrated document and shall be deemed to be the Annual Operating Agreement for the purposes of the British Columbia Transit Act, as amended from time to time.
- 2.2 <u>Amendments to Master Agreement: The parties agree to amend the Master Agreement as follows:</u>
 - (a) To remove Section 13 in its entirety and replace it with the following:

"SECTION 13 - INSURANCE

- 13.1 <u>Insurance:</u> The Operating Company and the Authority shall purchase and maintain in force throughout the term of this Master Agreement, insurance policies covering the perils specified herein as set out below. As evidence of insurance coverage, the Operating Company shall deposit with the Authority, copies of the insurance policies the Operating Company is required to purchase in accordance with this Master Agreement and the Annual Operating Agreement.
- 13.2 <u>Minimum Insurance Coverage Requirements</u>: The following insurance coverage shall be purchased and maintained throughout the term of this Master Agreement and the

Annual Operating Agreement:

1. Vehicle Insurance:

a) The Operating Company shall purchase and maintain insurance on all vehicles used by the Operating Company in the operation of the Public Passenger Transportation System under this Master Agreement as follows:

i) Third party liability insurance of Five Million Dollars (\$5,000,000.00) per occurrence purchased from the Insurance Corporation of British Columbia.

b) The Authority shall purchase and maintain insurance on all revenue vehicles used by the Operating Company in the operation of the Public Passenger Transportation System under this Master Agreement as follows:

- i) Third Party Liability insurance in excess of Five Million Dollars (\$5,000,000.00) to a minimum limit of Twenty-Five Million Dollars (\$25,000,000.00).
- ii) Collision or upset insurance \$5,000.00 deductible.
- iii) Comprehensive insurance covering hazards such as fire, theft, vandalism, glass breakage, falling trees, wind-storms, etc. \$500.00 deductible.

2. Physical Assets Leased from the Authority :(where applicable)

- a) The Authority shall purchase and maintain insurance on all Physical Assets leased from the Authority, pursuant to the terms of the individual lease agreements with the Operating Company and respecting said Physical Assets.
- b) Without limiting the generality of the foregoing, such insurance shall be in the name of the Authority and shall include a waiver of subrogation against the Operating Company. The insurance shall be in accordance with the laws in force and in effect in the Province of British Columbia and Canada.
- c) The amount of such insurance for the respective categories of Physical Assets shall be not less than as follows:
 - Buildings and Structures Including Leasehold Improvements. The Authority shall purchase and maintain insurance on all buildings and structures on a standard all risk form including boiler explosion, flood and earthquake where applicable, in an amount not less than the full replacement value thereof as determined by the Authority.
 - ii) Other Chattels and Equipment. The Operating Company shall purchase and maintain insurance on all chattels and equipment not otherwise insured under this Schedule against loss or damage from all risks, in an amount not less than the full replacement value thereof.
- d) The Authority may, in its sole discretion, self insure part or all of the insurance requirements hereunder.

3. Physical Assets Owned by the Operating Company or Leased from a Party other than the Authority

a) The Operating Company shall purchase and maintain insurance on all Physical Assets owned or leased by them from a party other than the Authority, to the same extent as specified in Section (2), above, except that contrary to Section (2) the Operating Company shall determine the full replacement value thereof.

4. Comprehensive General Liability Insurance:

- a) The Authority shall take out and maintain comprehensive general liability insurance (CGL) covering the operation of the Public Passenger Transportation System specified in Schedule "B" of the Annual Operating Agreement on an occurrence basis in an amount not less than Twenty-Five Million Dollars (\$25,000,000.00). Such insurance shall include the Operating Company and the Municipality as an additional insured party and further, the policy shall apply to each insured in the same manner and to the same extent as if a separate policy has been issued to each of the insured parties.
- b) The Authority's CGL does not extend to cover non-transit activities a company may be engaged in. If the Operating Company performs work outside of the terms of this Master Agreement and/or the Annual Operating Agreement, the Operating Company will require separate insurance coverage for that work which provides a waiver of subrogation in favour of BC Transit.

5. Additional Covenants:

a)The Operating Company covenants that it shall not knowingly permit, suffer, allow or connive at the use or operation of any vehicle in respect of this Master Agreement by any person, or in any way, or for any purpose, contrary to the provisions of this Master Agreement or the provisions of the Insurance (Vehicle) Act or any other applicable legislation and related regulations. The Operating Company shall indemnify and save harmless the Authority from any breach of this covenant. b)It is mutually understood and agreed that the responsibilities to acquire and maintain policies of insurance pursuant to this Master Agreement and/or the Annual Operating Agreement shall be restricted and limited to the provisions of this Section 13."

SECTION 3 - TERM AND RENEWAL

3.1 Term and Renewal: The term of this agreement shall be from April 1, 2013 to March 31, 2014 except as otherwise provided herein. It is acknowledged by the parties that in the event of termination or non-renewal of the Annual Operating Agreement, the Master Agreement shall likewise be terminated or not renewed, as the case may be.

- 5.1 <u>Amendment</u>: This Annual Operating Agreement and the Schedules attached hereto may be amended only with the prior written consent of all parties.
- 5.2 <u>Assignment</u>: This Annual Operating Agreement shall not be assignable without the prior written consent of the other parties.
- 5.3 <u>Enurement</u>: The Annual Operating Agreement shall be binding upon and enure to the benefit of the parties hereto and their respective successors.
- 5.4 <u>Pets on Buses</u>: Notwithstanding the provisions of Section 9.7 of the Master Joint Operating Agreement, pets on buses are permitted under guidelines agreed to by the parties to this agreement.
- 5.5 Alternative Funding Arrangements: For the period beginning on April 1, 2013 and ending on March 31, 2014, the Municipality shall contribute 100% of the Municipal Flex Funded amount identified in Schedule C, and the Municipality and the Authority shall share the balance of the remaining costs according to their funding contribution shares as per Section 7 of the British Columbia Transit Regulation, B.C. Reg 30/91.

Re: Clarification of Eligibility Criteria for Catering Endorsements and Clarification of

Where Catered Events may be Held at Licensed Establishments

The purpose of this policy directive is to clarify the eligibility requirements for catering endorsements and to clarify where catered events may be held at a licensed establishment. This supplements the information in policy directive 13-01.

Eligibility

Catering endorsements are intended to allow licensees to provide a full range of food and liquor service for their clients' events. The intention is that these events will primarily be held "off-site" (i.e., at locations other than the applicant's licensed establishment). A catering endorsement may not be used to alter the primary focus of the establishment or alter the terms and conditions under which the establishment operates on a day to day basis.

Licensees must hold a food primary or liquor primary licence to be eligible to apply for a catering endorsement.

Applicants must be able to demonstrate that:

- their licensed establishment prepares food on-site as part of its business;
- they have the infrastructure and personnel necessary to provide catering services. This includes a requirement to have a full commercial kitchen at their licensed establishment:
- their catering services will be focused on the preparation and service of food at other people's events; and
- the catered events will typically be held off-site.

Examples of liquor primary establishments that typically would qualify for a catering endorsement would be hotels, pubs, convention centres and conference centres.

The following are examples of liquor primary establishments that are generally considered ineligible for a catering endorsement due to the limited nature of their liquor primary licence (i.e. the establishments are event driven or do not provide significant food service):

- stadiums, concert halls, theatres and other live-event establishments;
- gaming facilities;

- motor vessels, trains, and aircraft;
- nightclubs; and
- airport lounges.

Events at Licensed Establishments

A licensee with a food primary or liquor primary licence may cater to events on the same property as their licensed establishment, as long as the event is held outside the establishment's licensed area (the area "red-lined" on the floor plan), and the licensee primarily caters to events held off-site.

On-site events must generally take place in an unlicensed banquet room or the equivalent, rather than other unlicensed areas of the establishment. Catered events may also be held on-site in unlicensed outdoor areas such as a courtyard, lawn or rosegarden, but may not take place in parking-lots.

Catered events may be held within the licensed area of a food primary or liquor primary establishment if the licensee applies to temporarily suspend its licence. This may only be done 4-6 times per year.
